Important message for the parents of the students of "Seth Anandram Jaipuria School, Sector 14-C, Vasundhara" Ghaziabad and to all concerned

Several news items have appeared in various newspapers regarding Seth Anandram Jaipuria School, Ghaziabad which are not based on correct facts and are misleading. As a responsible school, we would like to inform all stakeholders about the correct position.

- 1) Uttar Pradesh Self – Financed Independent Schools (Fee Regulation) ordinance , 2018 was promulgated on 09.04.2018 which was subsequently converted into an Act. Based on the provisions of the Act, the school had to determine fees payable for the academic year 2018-19.
- 2) The school management reduced the fees for the academic year 2018-19 in compliance with the provisions of the ordinance and the revised fees details was uploaded in the school website and also on the school notice board.
- 3) The parents filed a complaint with the District Fees Regulation Committee (DFRC) against the school as they were not satisfied with the revised fees. The DFRC, based on that complaint issued an order dated 10.01.19 which was challenged by the school in the Hon'ble High Court at Allahabad. The Hon'ble High Court issued an interim order staying the implementation of DFRC order and the matter is sub-judice and has been listed for 30.04.2019
- 4) Meanwhile the school was facing challenges regarding collection of fees from the parents. 47 parents were not paying the full fees of all the four quarters for the academic year 2018-19 to whom regular notices were being sent by the school authorities.
Despite repeated notices and requests to pay fees, these parents resorted to agitation instead of paying the fees. Despite this, the defaulting students were allowed to come to school and study for the whole year and enjoy all facilities, including transportation provided by the school. On 30th March 2019, the school struck off the names of 47 students after serving final notice to the parents.
- 5) The parents filled a writ petition in Allahabad High Court against the decision of the school and the last hearing was held on 26.04.2019 and the matter was adjourned to 30.04.2019. No order has been passed by the Hon'ble Allahbad High Court in this regard. Meanwhile 11 parents have paid the fees and their wards are studying in the school. The school has given an undertaking to the Govt. and other concerned authorities that it stands fully committed to the final order of the Hon'ble High Court both in relation to fees and action taken against the students.

In view of the facts mentioned above, we would request all concerned not to believe any rumours or wrong information given by individual or any publication. We would also like to appeal to all parents to maintain peace and harmony, in the overall interest of children and public at large.
